### WHAT CAN YOU EXPECT

Every position within EFSA, from scientists to managerial and technical staff, plays an important part in creating an inspirational environment in which to work and develop.

REPRO Department's vision is to contribute to the three key EFSA priorities which are:

(1) *Fit for purpose:* EFSA must ensure its advice is fit for purpose and perceived as useful to risk managers while meeting its core obligation of protecting EU consumers

(2) *Sustainability*: EFSA must ensure that it makes optimal use of the resources, internally by enhancing its efficiency and externally by improving its cooperation with national food safety agencies, European bodies and international organisations

(3) Trust: EFSA's scientific advice is central to the value of its work for European citizens.

REPRO Department's mission is to provide independent scientific advice on risk assessment of substances, products and processes intended to be used in the food chain and substantiation of claims made on foods. The Department relies on cooperation with competent authorities of the European Union Member States, as contributors and partners during the risk assessment. The customers and end-users of this advice is the European Commission, the European Parliament, Member States and applicant companies seeking market access for regulated products.

In light of the increasing globalisation of trade in foodstuffs and ingredients, the commitment to respond rapidly to urgent food safety-related incidents while at the same time addressing growing demands for timely evaluation of market access applications as well enhancing its communication and services to applicants in an open and transparent way, is high.

In addition, the Department is also responsible for developing guidance and providing advice on emerging safety issues related to products already authorized within the European Union.

The main scientific impetus of the Department is given by six scientific panels and five scientific units: the Food Ingredients and Packaging Unit, the Nutrition Unit, the Feed Unit, the GMO Unit, the Pesticides Unit. Together with its Applications Desk Unit, the Department is working to improve the efficiency of handling applications.

### Your key responsibilities

Reporting to the Executive Director of EFSA and as a dedicated member of the EFSA Management Team the successful candidate will:

- Provide intellectual, strategic and operational leadership in developing the Department's work program aiming at contributing to the three key EFSA priorities;
- Lead and manage the REPRO Department ensuring it fulfils its mission in line with the regulatory and financial framework within a challenging political and human capital environment;
- Develop and deploy a culture of service in interfacing with various stakeholders;
- Act as a catalyser and generator of innovation and changes;
- Contribute to enhance the reputation of the Authority by fostering the highest level of cooperation, integrity, independence, responsiveness and overall transparency in the provision of excellence in scientific output.



# WHAT ARE THE SELECTION REQUIREMENTS

You must satisfy the following requirements on the closing date for submission of your application:

### I. Eligibility criteria

#### 1. General requirements

- Be national of a Member State of the European Union, Iceland or Norway;
- Enjoy full rights as a citizen;
- Have fulfilled any obligations imposed on them by laws concerning military service;
- Be physically fit to perform the duties linked to the post.<sup>1</sup>
- Have a thorough knowledge of one of the EU official languages and a satisfactory knowledge of another EU language;
- Meet the character requirements for the duties involved.

#### 2. Qualifications

- A level of education which corresponds to completed university studies of at least four (4) years attested by a diploma in one of the following fields: food science, food technology, chemistry, biochemistry, toxicology, biology, microbiology, human nutrition, human medicine, veterinary medicine, epidemiology, dietary exposure assessment, life sciences or related areas; OR
- A level of education which corresponds to completed university studies attested by a diploma in one of the following fields: food science, food technology, chemistry, biochemistry, toxicology, biology, microbiology, human nutrition, human medicine, veterinary medicine, epidemiology, dietary exposure assessment, life sciences or related areas, and appropriate professional experience of at least one (1) year when the normal period of university education is at least three (3) years.<sup>2</sup>

#### 3. Experience

• At least **fifteen (15) years** of proven full-time professional experience<sup>3</sup> in some or all the fields covered by the job description above acquired after the qualifications mentioned in point 2.

### **II.** Competencies required

#### **Experience and Knowledge**

- i. At least **six (6) years** of professional experience in strategic leadership, in particular in scientific areas related to EFSA's remit;
- ii. Experience in facilitating and/or promoting scientific cooperation with a wide range of stakeholders;
- iii. Hands-on experience in budgetary, financial and human resources management in a national, European and/or international context;

<sup>&</sup>lt;sup>1</sup> Before appointment, a successful candidate shall be medically examined by an institution's medical officer in order that the European Food Safety Authority may be satisfied that he/she fulfils the requirement of article 28(e) of the Staff Regulations of the Officials of the European Communities.

<sup>2</sup> Only qualifications issued by EU Member State authorities and qualifications recognised as equivalent by the relevant EU Member State authorities will be accepted. In instances where diplomas are obtained from a non-EU Member State, EFSA may request the candidate to provide a relevant document of comparability issued by a recognised authority.

<sup>&</sup>lt;sup>3</sup> Professional experience shall be taken into account from the date on which the person fulfils the minimum qualifications or engagement. <u>Any given period may be counted only once</u> (in order to be calculated as eligible, years of studies or professional experience to be taken into account <u>shall not overlap</u> with other periods of studies or professional experience).Professional activities pursued part-time will be calculated pro-rata on the basis of the certified percentage of full-time hours worked.

Remunerated PhDs acquired in a field relevant to the job description can be counted as professional experience up to 50% of their duration.



- iv. Experience in scientific working processes, including the processing of regulated products applications and dossiers;
- v. Good knowledge of Risk Assessment principles;
- vi. Sound knowledge of EU food and feed safety principles and associated legislation;
- vii. Excellent knowledge of both written and spoken English.

- viii. Capacity to lead, guide and motivate staff with sensitivity and respect of diversity as well as ability to build trust and develop direct reports;
- ix. Ability to maintain a high sense of professional integrity, diplomacy and political astuteness;
- x. Ability to champion innovative approaches and drive cultural change within a dynamic yet regulated environment;
- xi. Ability to communicate effectively and persuasively to a broad range of audiences.

### WHAT CAN WE OFFER YOU

#### Life in Parma

Parma has around 200.000 inhabitants spread across 260 km<sup>2</sup>. The city has a rich cultural and historical heritage and has recently been ranked by "The Telegraph" as among the 20 best places in the world for the good life. The presence of music in its history is recognised worldwide and its food and wine traditions are well known. It is also within reachable distance to other major Italian cities.

#### Salary and benefits

EFSA can offer the selected candidate a contract of 5 years with the possibility of renewal.

The successful candidate will be recruited in Temporary Agent AD 12. The basic monthly salary for AD 12 step 1 (15 years professional experience after obtaining minimum qualifications) is  $\in$ 10,406.80 and for AD 12 step 2 (18 years professional experience after obtaining minimum qualifications) is  $\in$ 10,844.10, subject to an annual review of remuneration provided for in Article 65(1) of the Staff Regulations.

In addition to the basic salary, EFSA offers a range of benefits:

- Various allowances to which the successful jobholder may be entitled, such as a household allowance, expatriation allowance (16% of basic salary), dependent child allowance and education allowance. The salary is subject to a Community tax deducted at source and staff members are exempt from national taxation.
