#### **Organizational Setting**

The Animal Production and Health Division (AGA) promotes and facilitates the sustainable development of the livestock sector. It manages technical programmes and hosts technical networks in areas of animal genetics, animal feeding and pastoralism, among others. AGA integrates scientific, technical expertise and policy advice, it facilitates policy dialogue (including through intergovernmental bodies), encourages good governance, manages knowledge and provides information, analysis and technical assistance for the development and implementation of innovative solutions to improve livestock productivity in a sustainable manner.

The post is located in the Animal Genetic Resources Branch (AGAG).

The Unit generates information and manages knowledge, facilitates the development and implementation of innovative solutions and provides technical expertise to improve productivity, efficiency and resilience of livestock production systems. The activities of the Unit cover all production systems, from pastoralism to intensive systems, including crop-livestock integrated systems; and aim to enhance their sustainability in its three dimensions; environmental, economic and social.

The post is under the overall supervision of the Director AGA, the day-to-day supervision of the Senior Animal Production Officer, in close collaboration with colleagues from AGA and AGP, the Strategic Objective Core Teams and Decentralized Offices.

- Develops technical, analytical, monitoring and reporting frameworks, and related methodologies, tools, systems
  and databases etc. to support the planning, implementation/delivery and monitoring of programmes of work,
  projects, products and/or services;

- Promotes international cooperation/advocates best practices, increased policy dialogue and provides technical expertise at international/intergovernmental meetings;
- Participates in resource mobilization activities in accordance with the FAO Corporate strategy.

#### **Specific Functions**

- Identifies gaps in areas of tools, policies, indicators and knowledge to improve resilience in pastoral systems and to increase
  the visibility of these systems in international policy-related fora and meetings; develops tools and generates knowledge to
  bridge those gaps;
- Coordinates with other FAO divisions, other agencies and stakeholders working on pastoralism, and ensures that up to date
  and state of the art information is available in the pastoralists knowledge hub web portal and that capacity development and
  knowledge sharing activities targeting pastoral communities are organized, specifically through pastoralist field schools;
- Coordinates with other technical units to include mitigation of, and adaptation to, climate change impact in the framework of
  improving resilience, and develops pastoral and agro-pastoral risk early warning and response systems, including for land
  degradation;
- Provides technical advice to countries in emergencies, especially those in Level 3 emergencies.
- Faciliates technical discussions, networking and learning among regional teams in livestock, pastoralism and resilience in
  order to come up with policy and programming solutions and options in view of the various risks and dynamics across
  regions;
- Contributes to projects identification, formulation and technical support in the area of pastoralism and resilience of livestock production systems;
- Prepares documents and reports related to pastoralism and resilience;
- Supports and promotes the application of the Livestock Emergency Guidelines and Standards (LEGS) and FAO related guidelines and manuals.
