### Organizational Setting

The Regional Office for the Near East and North Africa (RNE) is responsible for leading FAO's response to regional priorities for food security, agriculture and rural development through the identification, planning and implementation of FAO's priority activities in the region. It ensures a multidisciplinary approach to programmes, identifies priority areas of action for the Organization in the Region and, in collaboration with departments and divisions at Headquarters, develops, promotes and oversees FAO's strategic response to regional priorities. RNE also advises on the incorporation of regional priorities into the Organization's Programme of Work and Budget and implements approved programmes and projects in the region, monitors the level of programme implementation and draws attention to problems and deficiencies. RNE develops and maintains relations with region-wide institutions including the Regional Economic Integration Organizations (REIOs). The Regional Office supports regional policy dialogue on food security, food safety, agriculture and rural development issues, facilitates the emergence of regional partnerships, and supports capacity development and resource mobilization for food security, agriculture and rural development in the region.

As part of FAO's global efforts to improving food safety, the FAO Regional Office for the Near East and North Africa (RNE) is hiring an international consultant to expand the Organization's efforts to strengthen national and regional food safety programs in the Arab region. FAO is increasingly supporting the progressive improvement of food control systems in the region and is in the process of strengthening its contribution to regional food safety coordination mechanisms and expand its assistance to the implementation of regional harmonized food safety standards and protocols in member countries. The incumbent will play an important role on the implementation of an existing regional food safety program and will assist the development of new food safety FAO Technical Cooperation Projects in the region.

### Reporting Lines

The consultant will work under the overall guidance of the RNE Regional Representative, the technical oversight of the Lead Technical Officer of the UNJP/RNE/010/UI project in AGFF, and under the day to day supervision of the Agro-Industry Officer (Agribusiness and Value Chains) in RNE.

### Technical Focus

Food safety, food control systems and Codex Alimentarius

### Tasks and responsibilities

- Support the implementation of FAO/UNIDO food safety project in the region. This includes the implementation of the following activities:
  - Review the Arabic translation of the FAO/WHO food control system assessment tool;
  - Assist the organization and conduction of regional workshop on harmonization of food control tools;
  - Facilitate the emergence of a regional network of professionals involved in Codex matters, through the creation of a common key contact list within region;
  - Analyse the current level of engagement and contribution of Arab countries in Codex proceedings, current convergence of discrepancies between Codex standards and Arab standards, current priorities and areas of interest/focus of Arab countries in Codex proceedings, and current level of engagement of national stakeholders in Codex-related activities;
  - Preparation of guidance supporting sound national processes aiming at strengthening countries participation in Codex;
  - Organize two Capacity Building Workshops to create regional dynamic around the identification priorities for the development of Codex Standards, best practices in applying Codex standards as a basis for national food safety

- standards and capacity building of Codex delegates on “Arab Guidelines for Contribution on Codex” currently under development;
  - Implement guidance in three pilot countries as basis for further regional validation and dissemination.
  - Improve FAO’s participation and technical contributions to Codex Coordinating Committee for the Near East (CCNEA);
  - Assess the opportunities for the development and implementation of FAO TCPs to support RNE’s active support on food safety and CODEX matters in the region;
  - Review and analyse the national framework for food safety for some countries in the region, and identify key types of support that FAO can provide to the countries;
  - Lead the development of a FAO plan of action to support the implementation of food safety activities to support member countries in the region.

- At least seven years of relevant experience at national and international level in food safety;
- Working knowledge of English and Arabic, French preferred.

- Experience working within or with state structures on similar issues are of advantage;
- Experience working with Codex Alimentarius;
- Experience in organizing and facilitating international meetings, seminars and training courses in the technical general area of food safety and agro-industries development.
