FAO seeks gender, geographical and linguistic diversity in its staff and international consultants in order to best serve FAO Members in all regions. Qualified female applicants and qualified nationals of non-and under-represented member countries are encouraged to apply. Persons with disabilities are equally encouraged to apply. All applications will be treated with the strictest confidence.

Organizational Setting

The FAO in Afghanistan assists the Government to develop policies, programmes and projects to address the root causes of hunger and malnutrition; to help the Government develop the agricultural, fisheries and forestry sectors and to use the environmental and natural resources in a suitable way. It participates in the development of FAO's field projects in the country and implements it, including the reconstruction and rehabilitation of the damaged relevant sectors.

FAO works with three counterpart ministries – the Ministry of Agriculture, Irrigation and Livestock, the Ministry of Energy and Water and the Ministry of Rural Rehabilitation and Development. The FAO Representation is based in Kabul with regional offices in Herat, Jalalabad, Kandahar, Mazar-e-Sharif, Kunduz and Provincial offices in Badakhshan, Bamyan, Kapisa and Parwan.

The post is located in the FAO project in Kabul – Afghanistan and will have frequent travel to project locations.

Reporting Lines

Under the general supervision of FAO Representative / Budget Holder (FAOR / BH) in Afghanistan with direct supervision of the Chief Technical Advisor / Team Leader (CTA/TLs) and in close consultation and cooperation with the National Project Coordinator the incumbent will undertake and be responsible for the following tasks.

Technical Focus

The Consultant will carry out the work plan for various key task and activities, preparing of mid-term report and final report, procurement of laboratory materials / equipment's, formulation of Standard Operating Procedure (SOP), external quality assessment schemes etc.

Tasks and responsibilities

- Provide direct assistance to the OSRO/AFG/402/JPN International Chief Technical Advisor (CTA) and to the National Project Coordinator to
 ensure that technical specifications for the procurement of laboratory equipment, consumable and diagnostic kits are appropriate and
 consistent with project activities and objectives;
- Work in close collaboration with the National Project Coordinator and the Director of the Central Veterinary Diagnostic and Research Laboratory (CVDRL) in Kabul to assess the status of the laboratory equipment and instruments and prepare proposal for replacement (if needed);
- Ensure (in close collaboration with the Director of CVDRL) that laboratory staff that will be involved in processing the biological samples collected under the OSRO/AFG/402/JPN project has all the necessary skill. If required the incumbent will provide the necessary re-fresh training;
- Provide assistance and guidance to the Director of CVDRL for the development and formulation of standard operating procedures (SOPs) ensuring that the laboratory methods are consistent with the requirements of the World Organization for Animal Health (OIE) for what concerns animal health and with the Codex Alimentary for what concerns food safety of animal origin;
- Provide assistance and guidance to the Director of CVDRL in the establishment of a management system to ensure that the quality of the testing process (including the quality of the diagnostic reagents used, the equipment and laboratory devices, chemical and biological reagents used in the testing process) provide confidence that the laboratories within the CVDRL fulfil requirements for quality;
- Facilitate the participation of the CVDRL in external quality assessment schemes/proficiency testing;
- Any other task (within the professional competence of the consultant) which may be assigned by the CTA or FAO-R.

CANDIDATES WILL BE ASSESSED AGAINST THE FOLLOWING

Minimum Requirements

- Adanced university degree in veterinary, animal health, livestock or field
- At least 07 years of relevant experience in the management of transboundary animal disease control programmes with specific reference to laboratory experience, which include experience in bio-molecular methods for the laboratory diagnosis of infection diseases of animals, or closely related field.
- Working knowledge of English, French or Spanish and limited knowledge of one of the other two or Arabic, Chinese, Russian.

Technical/Functional Skills

- Previous working experience in the region and familiarity with the country situation will be highly desirable

- Extent and relevance of experience in preparation of projects and programmatic approaches (particularly irrigation, project management and animal health or livestock projects) and in results-based monitoring and supervision of multidisciplinary projects
- Extensive field experience in developing countries.
- Proven experience in managing and coordinating the activities of a veterinary diagnostic laboratories
- Experience acquired with control programmes for FMD and other Trans-boundary animal diseases is highly desirable as well as understanding of the socio-economic context institutional set-up and challenges in relation to the control of FMD and other Trans-boundary animal diseases in developing countries.
- Ability to prioritize tasks work without direct supervision and promptly deal with urgent problems as they arise.
- Demonstrated capacity to write technical reports in English
- Relevance of experience in Asia and the Pacific region is desirable
- Knowledge of FAO's project approval processes and Field Project Monitoring and Information System (FPMIS) would be an asset
- Demonstrated analytical and conceptual skills with ability to analyse and integrate diverse information from various sources
- Familiarity with the UN Communications rules and procedures, experience in developing communications strategies for the UN is necessary.
